



## James C. Kennedy Jr.

January 7, 1934 - June 17, 2015

James Clifford Kennedy, Jr., 81, of Sunrise Beach, passed away Wednesday, June 17, 2015, at the Laurie Care Center. He was born January 7, 1934, in Akron, Iowa, the son of the late James C. Kennedy, Sr. and Marguerite (Brown) Kennedy.

On August 11, 1956, in Akron, Iowa, he was united in marriage to his high school sweetheart Janice (Robbins) Kennedy. In addition to his wife, he is survived by his children, Gene David Kennedy of the home, Kim Marguerite Lopez and husband Jim of Dayton, Ohio, John Robert Kennedy and wife Jane of Pleasant Hill, Missouri and Kay Ellen Kessling and husband Bill of Metamora, Illinois; five granddaughters, two great grandchildren; a brother-in-law, David Blanchard of Minnetonka, Minnesota and many other relatives and friends. In addition to his parents, he was preceded in death by his sister, Kathleen Blanchard.

Jim was a veteran of the United States Army, beginning with ROTC at the University of South Dakota at Vermillion, SD. He graduated from USD with a Bachelor of Science in 1957.

He was employed at Caterpillar Proving Ground and at Mossville as an engineer until his retirement, August 1, 1995.

Jim was a member of New Hope Lutheran Church LCMC in Laurie and Osage Community Elks Lodge #2705 in Laurie and the board of Cochurmin Homes. He freely gave of his time to his church and community.

Growing up, he spent his lake time at Lake Okoboji, Iowa with his parents and grandparents. While living at Lake of the Ozarks, he enjoyed boating and taking people for rides. He was a good boat driver for all of the waterskiing children. In their retirement years the Kennedys were blessed with good health for most of the time and were blessed by their friends and the love of their children and their families.

Funeral services with full military honors will be held at 11:00 a.m. Saturday, June 20, 2015 at the Kidwell-Garber Laurie/Sunrise Beach Chapel with Pastor Rick Bell officiating. The family will receive friends from 10:00 to 11:00 a.m. Saturday at the funeral home. Pastor Roger Kurtenbach will lead the graveside services and interment will be held at the Riverside Cemetery in Akron, Iowa at 3:00 p.m. on Monday.
